1. The Principal is informed to submit the following
 - i. One hard copies of nominal rolls downloaded from college login, along with Original payment receipt and photo copy of it.
 - ii. No dues certificate from Dean, College Development Council, SU.
 - iii. No dues certificate from Dean, Academic Affairs, SU.
2. In case of late registration and submission, a penalty of Rs. 5000/- per day for each semester should be remitted.
3. Applications of not eligible candidates are liable for rejection at any stage whenever they are detected. For this, the University will not be held responsible in any manner.
4. Examination fee should be collected from the students as per Notification.
5. Amount must be submit through ONLINE mode only (via Payment Gateway)
6. Transfer of money through NEFT/RTGS is not permitted.
