GUIDELINES FOR PRINCIPALS

1. The Principal is informed to submit the following

- One hard copies of nominal rolls downloaded from college login, along with original payment receipt and photo copy of it.
 - No dues certificate from Dean, College Development Council, SU.

- In case of late registration and submission, a penalty of Rs. 5000/- per day for each semester should be remitted.
